BADMINTON ASSOCIATION OF SIKKIM MEMORANDUM OF ASSOCIATION

- 1. The name of the Association is **BADMINTON ASSOCIATION OF SIKKIM** and here in after referred to as the ASSOCIATION.
- 2. The Registered Office of the Association shall be the situated at Gangtok, East District, The Association will have jurisdiction through out the State of Sikkim.

3. AIMS AND OBJECTS OF THE ASSOCIATION ARE:-

- a) To promote, encourage and improve the game of Badminton in the State of Sikkim.
- b) Diffusion of useful knowledge of all kinds of sports, particularly the game of Badminton.
- c) To control the game of Badminton throughout the State of sikkim.
- d) To advance and safeguard the interests of the game of Badminton in accordance with the rules and regulations of the Badminton Association.
- e) Encourage the participation of the youth throughout the State through its agencies at the district, sub-division levels and various Badminton Clubs.
- f) Coordinate and Encourage Tournaments all over the State and create a network for the game of Badminton to provide uniformity of purpose.
- g) To promote, control and if necessary invite outside Teams/Clubs to the state.
- h) To procure from Government such facilities as may be necessary for achievement of the Objects.
- i) To foster the spirit of sportsmanship and the ideas of Badminton amongst the students and members of the Affiliated Clubs and District Associations.
- j) To maintain a panel of approval Umpires and to do such acts as may be necessary for this purpose.
- k) To arrange, organize, authorize or control Badminton Tournaments.
- To add, alter, maintain and enforce rules and regulations for the control and governance of the game in Sikkim and to maintain discipline amongst the player, officials, clubs and affiliated Associations.
- m) To organize a proper coaching scheme for the benefit of all badminton

- players of the State and to impart training in the game of badminton and physical education.
- n) And generally do all such things as may be lawful, incidental or conducive to attainment of the foregoing objects or any of them.
- 4. The Association shall undertake all non political and other activities which may help to promote the objects of the Association.

RULES AND REGULATIONS OF THE BADMINTON ASSOCIATION OF SIKKIM.

1. NAME & JURISDICTION:

- I. The association shall be called the "BADMINTON ASSOCIATION OF SIKKIM" having its headquarter in Gangtok where all meetings under these shall be held.
- ii. The jurisdiction of the Association shall extend all over the State of Sikkim.

2. OBJECTS OF THE ASSOCIATION:

The aims and objects of the association are those as expressed in the memorandum.

3. **DEFINITION OF THE TERMS:**

In these Rules, unless there is anything repugnant in the subject or context.:

- a) The "ASSOCIATION" means the "BADMINTON ASSOCIATION OF SIKKIM".
- b) The "EXECUTIVE COMMITTEE" means the Executive Committee of the Association.
- c) The "GENERAL BODY" means the General Body of the Association.
- d) The "ASSOCIATED MEMBER" any club or organization affiliated to the Association.
- e) "Player" means a "Badminton Player" who is registered with an affiliated member of the Association.
- f) "TOURNAMENT" means any tournament run and conducted by the Association.
- g) "INDIVIDUAL MEMBER" shall mean a primary, life and Honorary member.
- h) The "OFFICE BEARER" means and includes the following:
- a. PRESIDENT-1
- b. VICE PRESIDENT-4
- c. GENERAL SECRETARY-1
- d JOIT SECRETARY-4
- e. TREASURER-1

- f. ASSISTANT TREASURER -1
- g. CHIEF COORDINATOR-1
- h. PUBLICITY SECRETARY-1
- joint publicity secretary-1
- j. EXECUTIVE MEMBER- 10
- 4. a. The term of the President shall be for four years unless he resigns before expiry of his term and he can be re-elected for two additional terms of four years each. However, in no case the total term shall exceed maximum period of 12 (twelve) years with or without break.
 - b. The term of the Treasurer shall be for four years unless he resigns before expiry of his term and he can be re-elected for one additional term of four years. However, in no case the total term shall exceed Maximum period of 08 (eight) years with or without break.
 - c. The term of the Hon. Gen. Secretary shall be for four years unless he resigns before expiry of his term and he can be re-elected for two additional term of four years each. However, in no case the term shall exceed maximum period of 12 (twelve) years with or without break.
 - d. Further, the President, the Hon. Gen. Secretary and the Treasurer shall automatically cease to hold their respective post on attaining the age of 70 (seventy) years.

5. POWER:

Without prejudice to the generality of the aims and objects as defined by the Memorandum. The Association shall have power to do all such acts as shall be deemed to be incidental or conducive to the attainment of the aforesaid objects.

6. MEMBERSHIP:

- i) The members of the Association will include all the founder-members included in the APPENDIX "A" hereto.
- ii) The membership of the Association is open to all the residence of the State and member shall remain valid till such time he/she remains the resident of the State
- iii) Membership shall include the President and General Secretary of the Affiliated District Badminton Associations or clubs, membership will also

be	given	to the	two re	epresen	tatives	ofa	ffiliate	ed clubs.

- iv) There shall be two categories of members, namely:-
- a) AFFILIATED MEMBERS HAVING VOTES: i)Clubs, ii) District Badminton Association iii) Colleges/Schools iv) Life Members
- b) LIFE MEMBER: The Executive Committee may enroll any person as a life member on payment of lump-sum subscription as per rule 8(a).
- b) INDIVIDUAL MEMBERS HAVING NO VOTES:-
- i) Primary Members: The Executive Committee may enroll any person as a primary member on payment of admission fee and subscription as per rule 8
 (c). A primary member is one who has enroll for the first time for a period less then one year.
- Annual Members: The Executive Committee may enroll any person as a Annual Member on payment of admission fee and subscription as per rule 8 (c).
- iii) Honorary Members: Persons of eminence who have rendered valuable services to the game of Badminton may be admitted as honorary members by the Executive Committee.

7. NEWAFFILIATION AND /OR ENROLMENT OF MEMBERS:

decided by the Executive Committee.	

The Executive Committee shall have the right to reject any application for affiliation without signing any reason whatsoever. In such case the application fee shall be refunded.

8. FEES:

- a) Life Members: A lump-sum subscription for a life member shall be of Rs. 10,000/- in case of Badminton Player who have represented the country in at least three matches, the lump-sum subscription shall be Rs. only.
- b) The annual subscription shall be as follows:

i.	Primary Member	: Rs
ii.	Annual Member	: Rs
iii.	District & Subdivision Badminton Association	: Rs
iv.	Clubs	: Rs
V.	Schools/Colleges	: Rs.

- c) A primary member and an annual member shall be required to pay an admission fee of Rs. ... and Rs. respectively and or the rate of admission fee as will be determined by the Executive Committee from time to time in addition to the annual subscription at the time of enrolment.
- d) A Club and the College/School seeking affiliation shall be required to pay an admission fee of Rs. In addition to the annual subscription.

9. **DATE OF PAYMENT:**

- a) Annual subscription of all affiliated members and the individual members shall become due and payable on or before first day of January every year.
- b) No member shall have the right of vote in any meeting of the Association or of a Committee thereof unless the subscription for the year and other dues, if any have been paid.

10. ACCOUNTING YEAR:

The accounting year of the Association1st April each year to 31st March of the following year.

11. TERMINATION or SUSPENSION

a. If an affiliated unit, associate member or official directly or indirectly connected with the Association refuses or neglects to comply with any provision of the Rules or is guilty of such conduct as the Executive Committee deem likely to affect the character or stability or interest of the Association, such official or affiliated unit or associate member shall be liable for expulsion or suspension for such periods as the Council may fix by a resolution provided that not less than 2/3 of the members of the Council present at such meeting shall have voted in favour of the same, provided also that at least 14 days before the meeting, at which such a resolution is passed, he/ she shall have had notice thereof and of the intended resolution, for his/ her expulsion or suspension and that he/ she shall at such meeting and before passing of such resolution, have had an opportunity of giving orally or in

writing any explanation or defence he / she may think fit, refusal to accept the service of notice shall be regarded as service of that notice. On the adoption of such resolution official or affiliated units or associate member shall not have any claim against the Association.

- b. In respect of players, the Executive Committee shall be competent to take action by bare majority after calling for an explanation. Pending enquiry, interim action can be taken by President / Secretary. Also when the punishment proposed is for more than two years in respect of individual, directly or indirectly connected, the Executive Committee is to take action by two third majority on the basis of explanation available.
- c. If any club affiliate or individual affiliate refuses or neglects to comply with any provisions of the rules or is guilty of such conduct as the Executive Committee deem likely to effect the character or stability or interest of the Association, such Club Affiliate or Individual Affiliate shall be liable for expulsion or suspension for such period(s) as the Council may fix by resolution provided that he / she / club(s) have had an opportunity of giving orally or in writing any explanation or defence he/ she / it may think fit. On the adoption of such resolution club affiliate or individual affiliate shall not have any claim against Association. It is made clear that in respect of the club affiliates or individual affiliates, the Council shall be competent to take action by bare majority.

12. REAFFILIATION:

An affiliated member which ceased to be a member of association, either by voluntary withdrawal or by forfeiture of membership or otherwise may apply for renewal of its membership within five years. The defaulting member or members shall be required to pay all arrears and other dues if any, together with a renewal fee of Rs. 1000/- along with the application for renewal. The Executive Committee may, however, reject any such application without assigning any reason and in that case the renewal fees only will be refunded.

13. REGISTER OF MEMBERS:

A register of members shall be kept in which shall be set forth correct names, date of enrolment and addresses of the members. Any notice sent under certification of posting to the recorded address of the members shall be sufficient evidence of such service.

14. MANAGEMENT:

The affairs of the Association shall be conducted, managed and administrated by the Executive Committee to be constituted as follows:

- a. PRESIDENT-1
- b. VICE PRESIDENT-4
- c. GENERAL SECRETARY-1
- d. JOIT SECRETARY-4
- e. TREASURER-1
- f. ASSISTANT TREASURER -1
- g. CHIEF COORDINATOR-1
- h. PUBLICITY SECRETARY-1
- i. JOINT PUBLICITY SECRETARY-1
- j. EXECUTIVE MEMBER- 10

15. POWER SOFTHE EXECUTIVE COMMITTEE:

The management of the business and affairs of the Association shall be vested in the Executive Committee....in addition to the powers and authority by the Rules..... Conferred upon them, may exercise all such powers....such as may be necessary or expedient for conducting the affairs of the Association. The Committee shall, save as provided herein before, have the following powers:-

- a) To carry out the objects of the Association specified in the Memorandum of Association.
- b) To frame rules regarding the qualification of the players and clubs not repugnant to these rules.
- c) To manage and administer funds of the Association.
- d) To take action as may be deemed proper against an affiliated member, its member, Members of the Executive Committee, life, Primary and Annual members for misconduct and maintenance of discipline provided that before taking any action, the Executive Committee shall give the party concerned an opportunity of being heard.
- e) To decide all disputes or question referred to it.

- f) To make bye-laws not repugnant to these rules.
- g) To appoint a manager for the State Team amongst the members of the Executive Committee.
- (h) To appoint a representative or representatives from amongst the members of the Executive Committee to represent the Association on the Board of Control for Badminton Association of India or any State Body or any organization.
- (i) To procure, accept, collect and receive subscriptions, donations, gifts, legacies, contributions and endowments.
- (j) To nominate the Hony. General Secretary or any other member or members to act on their behalf with full authority to sign any deed or documents or to give a a valid and effectual discharge as if all members of the Executive Committee have been acting jointly.
- (k) The Executive Committee shall have the power to revise the rate of subscription and! submission fee for Primary, Annual and life Members and the entry fee for tournaments.
- (l) To consider and approve the Draft Annual Report of the Hony. General Secretary and the statement of accounts prepared by the Treasurer.
- (m) To call upon any affiliated club! organization to produce any such books, letters or documents required.

16. VOTING:

- (a) Voting on any matter of the Club shall be by show of hands. 1be President or Vice-- President or any person presiding over the meeting may direct that such voting may be by show of hands or by ballot as the President may determine.
- (b) The affiliated Associations/Clubs to BAS shall have two voting rights to cast their votes for the Executive Body of the Badminton Association of Sikkim. Any member who is continuously a Member of Badminton Association of Sikkim of 3 years and had paid the membership fees regularly without a gap in between the years will be eligible for casting the vote on the 4th year.
- (c) In case of equality of votes of any issue at any meeting, the President shall have a casting vote.
- (d) Every matter, arising at any General Meeting and at any meeting of any Committee shall be decided by a majority of votes.

17. QUORUM:

- (a) At -. least one fifth of the members present in person and eligible to vote shall form a quorum at the Annual General Meeting or any other General Meeting.
- (b) At -. least five members present in person shall form a quorum in a committee meeting.

18. DUTIES AND POWERS OF THE PRESIDENT:

The President shall preside at the Annual General Meeting, Special General meeting and Committee Meetings. The President shall exercise superintendence over the office bearers in the discharge of their duties. An powers and privileges of the accepted parliamentary procedure shall be voted in him. In his absence, the Vice -President shall preside and in the absence of the Vice-President, the meeting shall elect the Chairman.

The President may, under extraordinary circumstances, take an emergency decision and get the same ratified by the Executive Committee at the earliest possible.

19. DUTIES AND POWERS OF THE VICE-PRESIDENT:

The Vice-- President shall normally discharge all the functions of the President in his absence.

20. POWERS AND DUTIES OF GENERAL SECRETARY:

The General Secretary shall:

- (a) Convene all meetings in consultation with the... and Chairman of different committees and shall be......of all proceedings and resolutions of all such meetings to be correctly recorded in a book specially provided for the purpose and such minute shall upon question put and votes taken thereon, when signed by him, shall be conclusive evidence of the correctness of the entry.
- (b) Conduct alt correspondences of the Association and shall be in charge of all records, documents and properties and shall maintain an inventory of the same.
- c) Keep up to- date register of all affiliated members, life members, primary members and Annual members.
- (d) Conduct all affairs of the Association according to the rules and bye laws but shall not deal with any matter involving any question of policy, consultation

- or incur expenditure of the Association without previous approval of the Executive Committee.
- (e) Prepare every year the Annual Report on the working of the Association and place the same at the Annual General Meeting of the Association after duly approved by the Committee.

21. DUTIES AND POWERS OF THE SECRETARY:

- (a) Shall carry out all duties and functions entrusted to him by the Executive Committee.
- (b) Shall help the General Secretary and act for him during his absence and perform all duties of the General Secretary as provided in these Rules.

22. DUTIES AND POWERS OF THE TREASURER:

The Treasurer shall:

- (a) deposit all money as and when received into the accounts of the Association with Banks;
- (b) have charge of all funds of the Association;
- (c) cause to maintain the books of Accounts;
- (d) check, pass bills and vouchers and make all payments;
- (e) operate the Banking Accounts of the Association in conjunction with the President or Vice-President:
- (f) present the audited accounts at the Annual General Meeting of the Association;
- (g) keep an imprest cash of Rs _. _____. for urgent expenses.

23. DUTIES AND POWERS OF THE ASSTT. TREASURER:

The Asstt. Treasurer shall help the Treasurer and act for him during his absence and perform all duties of the Treasurer provided in these Rules.

24. ELECTION TO THE EXECUTIVE BODY:

- (a) Persons seeking election to the Executive Committee must have been a member of the Badminton Association of Sikkim at least for a period of three years.
- (b) Detailed process of the election shall be prescribed by the Executive Committee in advance.

25. GENERALMEETING:

The supreme authority of the Association shall vest in the General Meeting of members. It shall maintain general supervision over business of the Association in particular over the acts of the Executive Committee and shall be competent to take all steps that may be considered necessary and expedient in the interest of the committee or the Association at large.

26. SPECIALMEETING:

Special meetings may be held as often as may be considered necessary by the Executive Committee.

27. AMENDMENTS OF MEMORANDUM AND RULES OF THE ASSOCIATION:

- i. The Association shall have the power to alter, extend, or abridge the purpose for which it is established.
- ii. The rules of the Association may be amended or added to only by a special General Meeting convened for the purpose.
- iii. No amendments or additions can, however be made unless it is carried by a majority of at least3/4th of the members present in person and entitled to vote at such meeting.

28. **ABSENT FROM THE MEETING...**

If any member of the executive committee absents himself for three consecutive meetings without prior intimation, he ipso facto vacates his seat on the Executive Committee.

- 29. If upon dissolution of the Association, there shall remain after the satisfaction of all. its debts and liabilities, any property whatsoever the same shall not be paid to or distributed amongst the members of the association or any of them but shall be given to-some society on such terms and conditions to be determined by the vides of not less than three fourth of the members presents in person or in default thereof as the appropriate court or the Government may determine in that behalf
- 30. The Association may sue or be sued in the name of the General Secretary.
- 31. Any matter not provided for in these rules shall be dealt with by the committee.

32. VACANCIES AND HOW VACANCIES TO BE FILLED UP:

- a) Office Bearers the office of any office bearer shall fall vacant by the holder's death or resignation. A club or an Association or an Organization shall normally have no power to withdraw an office bearer if he has already been elected as such as a representative of the club an Association or an Organization attending an Annual General Meeting.
- b) (How the vacancy to be filled up):
- The Executive Committee shall have the power to fill up any vacancy of office bearers and members of the Committee.
- Vacancy to the office of elected members only, caused by the members death or resignation or for other reasons for which his name has been removed from the membership shall be filled from the same constituency if such member belonged to by the committee.

33. FUNDS:

- a) The Funds of the association shall comprise subscriptions, donation from members or well-wishers ,profits or interest on deposits and investments and receipts or like nature.
- b) The funds of the Association shall be kept in such Bank or Banks as the executive Committee may decide.' All collections shall be first deposited into such accounts.
- c) The Executive Committee shall be responsible for protection and proper application of funds and properties of the Association. The Accounts maintained in the Bank of Banks shall be dealt with and operated upon jointly by the President and Treasurer of the Association.
- d) The Treasurer shall give detailed accounts to the Executive Committee in the Annual General Meeting.

34. INTERPRETATION OF THE RULES:

The committee shall be sole authority for interpretation of these rules and of the bye-laws and regulations made there under and decisions taken under the rules or upon any question or interpretation or upon any matter affecting the Association and not provided for in these rules or bye-laws or regulation made there under, shall be final and binding on the Members.
