However, in case of huge entries, the Referee in consultation with Organising Committee, Chairman, Tournament Committee and Convenor, Tournament Committee may conduct qualifying matches in best of 3 games of 15 Points each with extension up to 21 points.

Shuttles:- Yonex or of the same standard flight shuttle will be used.

**Regulations** :: The BAI Competition Regulations and General Competition Regulations shall be applicable. In the event of any dispute, the decision of the Tournament Referee will be final.

Players have to make their own arrangements for Food & Accommodation.

**Clothing** :: Players must comply with General Competition Regulations of BAI.
