RULES & REGULATION OF THE CHAMPIONSHIP

1. All matches in the draw shall be played on best of three games of 21 points in rally point system. However, in case of huge entries, the Referee in consultation with Organising Committee, Chairman, Tournament Committee and may conduct qualifying matches in best of 3 games of 15 Points each with extension up to 21 points.
2. The entries are to be received through participants/ clubs/associations with name and State Players ID Number only. No entries will be allowed without BAS players ID. The Name of Doubles Partners is mandatory in the Doubles event.
3. The criteria for the age under the reference date & year 2022 are as follows:-

| Age under the reference Date & Years | |
|--------------------------------------|-------------------------------|
| Under 11 years | Born on or after (01/01/2012) |
| Under 13 years | Born on or after (01/01/2010) |
| Under 15 years | Born on or after (01/01/2008) |
| Under 17 years | Born on or after (01/01/2006) |
| Under 19 years | Born on or after (01/01/2004) |

4. All Entry fees to be paid by all players before the date of draw of the fixtures.
5. Yonex or of the same standard flight shuttle will be used.
6. All the players should bring their own playing kits, towels and water bottles.
7. All clothing worn by players shall be acceptable Badminton Sports Clothing. It is mandatory that , in doubles both players should wear same color clothing. The name of the player on the back of the T-shirt . Lettering shall be in capital letters in the Roman alphabet and in one single color contrasting with that of the T-Shirt. Lettering must be a height of 6cm and a maxs 10 cms. lettering should be horizontal, and placed near the back top of the Tshirt.
8. Players arriving late for the match, resulting in disqualification.
9. Players' failing to comply with the players' code of conduct will result in disqualification.
10. Players have to make their own arrangements for accommodation.
11. The organizing committee will provide water / Juices to the players during the tournament dates
12. Last date of entries :- 30th July 2022.
13. Date of withdrawal :- 1st August 2022.
14. Date of Fixtures:- 2nd August 2022
15. **PROTEST:** The fees for lodging protest of any kind shall be Rs. 1000/-. This fee shall be retained by the BAS for the event. Any protest shall be addressed to the Org. Secretary in writing within one hour after completion of the match or 4 hours before commencement of the match
16. Regarding any disputes the decision of the Organizing Committee & Chief Referee will be treated as final.
17. During the game the decision of the Technical officials will be treated as final.
